1. Deadline for retention of numbers: December 15, 2018.
2. Ice Racing and Snocross numbers will be issued from December 15, 2018 on a first come basis.
3. Youth Motocross riders and Youth Dirt Track Riders who qualify age-wise, may also be eligible for the Novice or Intermediate Class (Check your rule book for conditions).
4. Unless otherwise indicated in brackets ( ), **Minimum** age is 13 on the birthday of the rider.
5. Fee – \$80.00 (Youth Class Trials \$30.00)
6. After September 1, 2019 Licence Fee for 2019 becomes \$30.00 for all categories.
7. Motocross riders who wish to be endorsed for AMA Pro Licences or to obtain an FIM Licence (except Youth class riders) must have Pro status. Eligibility is at discretion of CMA office.

Instead of obtaining your signed consent at each and every event you attend, we ask that you sign and date this form indicating your agreement to provide information.

### Agreement

I have read the foregoing explanation and agree that my name and the nature of the treatment I receive due to injury at a CMA sanctioned event may be provided to the Canadian Motorcycle Association by the medical crew. I understand this information will be kept in a secure place and used only to compile general statistics, or in the event of an insurance or legal issue.
